- 1) Age Limits: 18 years to 38 years. Upper age limit is relaxable for Govt. Servants as per rules. 5 yrs. relaxation for SC & ST candidate (i.e. 43 yrs.) & 3 yrs. relaxation for OBC Candidates (i.e. 41 years), 10 years relaxation for Persons with disabilities as on last date of form submission as mentioned above i.e. 22nd March, 2024.
- The number of posts shown above may be increased or decreased according to the vacant posts available in the Department at the time of completion of recruitment process.
- 3) 1(one) post each is reserved for Person with disabilities (PwD) for the post of Social Worker(LD) and Outreach Worker(VI) and reservation will be horizontal in nature.
- 4) Scheme of Examination for various categories of posts from Sl.No. 2 to 13 will be as per O.M No.1/22/2005-DR-III/DP dated 18<sup>th</sup> September,2021 issued by the Department of Personnel & Administrative Reforms (Personnel Division), Govt of Manipur. - 5) The willing and eligible candidates should get their names sponsored from the concerned District employment Exchange Offices on or before 20th March, 2024.
- 6) Payable Fees: Rs.500/- for UR and Rs. 300/- for ST/SC/OBC. Fees shall be exempted for PwD candidates. Fees shall be paid online.
- Eligible candidate for the post shall download Admit Cards from Deptt's official website www.socialwelfare.mn.gov.in for appearing Written Test Examination on or before 3<sup>rd</sup> April, 2024.
- 8) The above notification is issued with concurrence of competent authority and with the approval of the State Cabinet for relaxation of ban on direct recruitment on contractual basis.
- 9) Disqualification:
  - (i) Canvassing by a candidate directly or indirectly in connection with the recruitment shall be liable to disqualification of the candidate.
  - (ii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions, will be disqualified.
  - (iii) Any candidate with criminal record, if any, will be disqualified at any stage (even after completion of recruitment process) upon receipt of adverse report from District Administration/Police during verification of antecedents and character.
