No. 6/44/2021-D(SW)Pt.(CMWPS): It is hereby notified for information of all eligible and interested widows and Aged persons who are not beneficiaries under National Social Assistance Programme (NSAP) & MOAP may apply for availing monthly pension benefits under Chief Minister's Widow Pension Scheme, Manipur Old Age Pension Scheme or one time financial assistance under National Family Benefit Scheme (NFBS) whichever is applicable.

2. Application format of the Scheme may be downloaded from the website www.socialwelfare.mn.gov.in.

3. Eligibility:


a) "Chief Minister's Widow Pension Scheme"

Eligibility Criteria

The assistance under the scheme is applicable for those widows belonging to Economical Weaker Section whose income is less than Rs. 72,000/- per annum. The other eligibility criteria and the scale of assistance under Chief Minister's Widow Pension Scheme:

i) Widows whose age is between 40 Years upto 59 years		Documents required: 1) Aadhaar Card details 2) Bank Account details 3) Death certificate issued by Registrar /Sub-Registrar of death and birth. 4) Income Certificate (issued by competent officer)/NFSA card details (Income is less than Rs. 72,000/- per annum). 5) 2(two) passport size photograph 6) Age proof certificate issued by the competent Authority 7) Certificate issued by the competent authority in respect of HIV positive Widows and HIV positive single women.
ii) For HIV positive Widows and HIV positive single women, the age shall be between 18 years upto 59 years.

* Widow pension shall be discontinued if the pensioner gets re-married or is in a live-in relationship with another person.



b) National Family Benefit Scheme(NFBS):

Eligibility Criteria:

Rs. 20000/- will be given as a lumpsum assistance to the bereaved household in the event of death of the bread-winner. It is clarified that any event of death (natural or otherwise) would make the family eligible for assistance. A woman in the family, who is a home maker, is also considered as a 'bread-winner' for this purpose. The family benefit will be paid to such surviving member of the household of the deceased poor who after, local inquiry, is found to be the head of the household.


6. Exclusion criteria
