The recruitment process(DPC) conducted in pursuance of Advertisement/Notification No.1/1/2017-ICDS/PMMVY dated 11-01-2019 issued by the Department for contractual engagement against 34 posts/position under Pradhan Mantri Matru Vandana Yojana(PMMVY) and the Special DPC conducted in pursuance of Notification No.1/1/2017-ICDS/PMMVY dated 03-03-2020 and all the related communications/corrigenda if any, issued by the Department in this regard, stand cancelled. **ORDERS**

**No.4/6/2017-S(SW)Pt:** Whereas vide Advertisement/Notification No.1/1/2017-ICDS/PMMVY dated 11.01.2019, applications were also invited from eligible candidates for engagement on contractual basis for various positions / posts at the State PMMVY Cell and District PMMVY Cells under Pradhan Mantri Matru Vandana Yojana of Umbrella ICDS; and

2. Whereas, on perusal of the above-mentioned Advertisement/Notification, it has transpired that reservation of posts for district/ block level positions for OBC, ST, etc. has been made on the basis of total number of said posts by ignoring these levels, while as per said Advertisement/Notification, recruitment was to be made district wise/block wise; and

3. Whereas, the reservation norm for OBC, ST, etc. should have been applied at the district level or block level as the case may be, wherever applicable; and

4. Whereas, it has also transpired that the scheme of examination for selection of candidates through the said recruitment process has not been indicated or notified for any post / position in the said Advertisement/Notification; and

5. Whereas, in view of discovery as mentioned at paras 3 and 4 above, the recruitment process is considered to be incorrect and irregular; and

6. Whereas, further, in compliance of the Hon'ble High Court's Orders dated 27.12.2019 and 22.01.2020 passed in connection with WP(C) No. 327, 27, 46, 97, 122, 133, 134, 158, 202, 209, 238, 239, 260, 353, 728 of 2019 and WP(C) No. 46 of 2020 respectively, a Special DPC was held after Notification thereof vide No.1/1/2017-ICDS/PMMVY dated 03.03.2020, for considering the suitability of some or all of the petitioners as may be concerned for selection against the various posts/positions notified for recruitment under the relevant scheme as per para 1 above. The candidates appearing in the Special DPC are to be selected for engagement against available posts/positions by considering reservation status of the post/position, category to which the candidate belongs (such as UR, OBC, ST, SC, etc.) and marks scored by the candidates in the scheme for assessment of candidate. However, in this case as well, since the reservation norm has been wrongly applied as mentioned earlier and the scheme of examination had also not been notified, hence, the said Special DPC held earlier is also liable to be cancelled.

7. Now therefore, the Governor of Manipur is pleased to cancel the Advertisement/Notification dated 11.01.2019, as mentioned at para 1, and all modifications, addendum or corrigendum thereto, if any; and the Special DPC held in pursuance of Notification dated 03.03.2020 as mentioned at para 6 above, and all modifications, addendum or corrigendum thereto, if any; and to further order renotification of the said recruitment for taking up recruitment with correct application of reservation norms, notification of scheme of examination and by duly observing relevant scheme guidelines.

The Special DPC shall also be conducted for the petitioners/candidates concerned, in compliance of orders of Hon'ble High Court in the litigations mentioned at para 6 above.

8. Director, Social Welfare Department is further directed to issue re-notification/notification within 45(forty -five) days of the issue of this order with due approval of the Government.
