GENERAL INFORMATION OF APPLICANT

A. Eligibility Criteria:

- (1) The applicant should be a domicile of the State of Manipur.
- (2) The marriage should take place in Manipur and both the husband and wife should be living together at the time of applying this scheme.
- (3) The marriage should be registered with the Registrar of Marriage and it shall fulfill the following conditions, namely:
 - (i) neither party has a spouse living at the time of marriage;
 - (ii) at the time of marriage, neither party: -
 - (a) is incapable of giving valid consent to it in consequence of unsoundness of mind;
 or
 - (b) though capable of giving a valid consent, has been suffering from mental disorder of such a kind or to such an extent as to be unfit for marriage and the procreation of children; or
 - (c) has been subject to recurrent attacks of insanity or epilepsy;
 - (iii) The bridegroom has completed the age of 21 (twenty-one) years and the bride the age of 18 (eighteen) years at the time of marriage.
 - (iv) The parties are not within the degrees of prohibited relationship, unless the custom or usage governing each of them permits of a marriage between the two;
 - (v) Neither of the party is an idiot or lunatic,
- (4) At least one of the parties to the marriage should be a person with disability and shall be supported by the certificate issued by the competent authority.

B. Mode of applying:

The application should be submitted through the respective District Social Welfare Officer, Manipur. The application shall be accompanied by the following documents: -

- (i) Marriage Registration Certificate issued by the Registrar of the Marriage Registration Office, Government of Manipur.
- (ii) Disability Certificate issued by the competent authority;
- (iii) A certificate from the concerned District Social Welfare Officer, Manipur to the effect that both the husband and wife are living together at the time of applying this scheme;
- (iv) A declaration to be jointly signed by both the parties that day will not resort to separation or breakage of marriage except under legal provisions.
